## TERMS AND CONDITIONS OF CREDIT ACCOUNT

Flat Rock Bagging and /or East Ohio Bagging (Creditor) reserves the right, at any time to suspend the credit, revise the stated credit terms provided herein, or withhold the sale or delivery of goods when the Creditor, at its sole discretion, deems such action necessary to protect its interests.

**Payment Terms** - The undersigned agrees to pay for all services according to the terms of "Net 30 Days", unless otherwise noted. Applicant will be invoiced at the time of pick up or shipment of each order. Payments may be applied against open charges at the discretion of Creditor. Accounts that remain unpaid for 45 days after invoice due date are subject to recourse by the Creditor, including suspending all credit privileges and/or being placed on C.O.D. status without prior notification to the Applicant. Suspended accounts will require payment and/or an alternative repayment schedules authorized through the Credit Department before charge privileges are reinstated. Delinquent accounts may be required to reapply for a Credit Account privileges with Creditor. Legal action will be taken on all accounts that remain unpaid for 60 days, unless arrangements are made with the Credit Department for an alternative repayment schedule. If a Credit Account falls delinquent, the Creditor reserves the right to modify any special prices quotes or volume discounting established for the customer.

**Attorney Fees** - Applicant expressly agrees that they shall be liable and pay all expenses, including but not limited to collection or court costs associated with the enforcement of any term of this Application and attorney's fees and court costs resulting from a default under this Application. Acceptances by Creditor of less than full payments shall not be a waiver of any of its rights.

Applicant agrees that all issues and disputes relating to the credit arrangement extended hereunder shall be governed in accordance with a competent jurisdiction chosen at the discretion of Flat Rock Bagging or East Ohio Bagging and that Applicant expressly waives its venue rights without reference to conflicts of laws principals.

**Returns** - Products may be returned, with prior approval from Flat Rock Bagging within 60 days from the date of purchase. Items returned must be in the original packaging, in resalable condition and accompanied by a dated invoice. At Flat Rock Bagging's discretion, returns that do not meet these criteria may not be accepted for refund. Returns are subject to a 15% restocking charge and all special orders are non-returnable.

**Dispute of Invoices** - Applicant agrees to examine immediately upon receipt, each of the Creditor's statements and to advise the Creditor of any disputed transaction or statements within 10 days of receipt, together with a written statement specifying the reasons for such dispute. Failure to notify Creditor of any dispute with respect to defective goods or billing shall constitute a waiver of all such disputes.

**Change of Ownership** - The Applicant agrees to notify the Creditor in writing of any changes of name or address, or any corporate reorganization or change of ownership with results in a change of name or principal place of business of Applicant.

**Email Contact** - By supplying my contact information, I authorize Flat Rock Bagging / East Ohio Bagging to contact me via e-mail about its products and services including: my account information, pricing, product information and special offers.

Nothing contained herein or within the application shall obligate Creditor to extend credit to Applicant in any amount. It is understood and agreed by the parties that any extension of credit or sale of goods to Applicant by Creditor shall be governed by the terms and conditions of this agreement and by the state laws of Michigan.
